## IMPORTANT - PLEASE READ

### NO PLAYER WILL BE PERMITTED TO TRAIN OR PLAY UNLESS ALL FEES ARE PAID IN FULL - NO EXCEPTIONS.

Only applications with the appropriate fee will be submitted to the committee for approval. All fees are strictly non-refundable.

The membership fee will be refunded only if the committee does not accept the application.

Players may ONLY be registered in their correct age group according to the year of their birth. Players wishing to play above their correct age group will be required to apply to the committee IN WRITING, for special consideration. Leave to 'play up' will only be granted where a player can show exceptional grounds to do so.

All players will be required to participate in player assessment. Parents of junior players should be aware that coaching fees will be payable over and above club registration fees where the services of a paid coach are employed for your team.

I/My child\* agree(s) to abide by the rules of NCFC's constitution, by- laws and policies (copies are available on request) and to comply with all rules & regulations of or administered by the FFV;

I/My child\* agree that allocation of players to teams will be at the discretion of the club, its coaches and the committee of management and that no further correspondence will be entered into.

I/my child\* consent to any image of me/my child\* to be used by NCFC to promote the club and soccer in general for my/our\* details being included on the NCFC database for use by other divisions within the club for marketing purposes.

Although players are covered by the FFV Group Personal Accident Insurance whilst training or playing, I/we\* understand that NCFC will not be liable for any costs not covered by the FFV insurance and additional costs must be met by the individual player. NCFC strongly recommends that all players are covered by their own private health insurance.

All players participating in the U12 age group and over are required to attend the club's player assessment sessions as this will be used to assess the participant's skills and football knowledge to enable staff to provide suitable training drills and structure for the year ahead.

Applicants/players agree to pay all fees owed promptly within the terms advised annually unless otherwise agreed upon by the Nunawading City Football Club's Committee of Management. I understand that there is a compulsory grounds levy of \$30 per annum. This will be refunded next year against registration fees if duties are carried out & have been signed off.

Parents of SSG & junior players/members agree to support the Committee of Management in maintaining and sustaining the facilities provided by the Nunawading City Football Club.

Parents of SSG & junior players/members are required to cooperate and facilitate with the Committee of Management and staff of the Nunawading City Football Club by assisting both at practice sessions and match days in accordance with a 'roster system' devised by the Team Manager. All members shall be assigned specific tasks by their respective Team Manager based upon a rotating schedule and agree to assist Coaches, Team Managers and NCFC as required. Satisfactory performance of your duties will ensure the refund of you grounds levy in the following year.

I/My child\* agree(s) to communicate openly with the Committee of Management and staff of the Nunawading City Football Club if any problems arise and to assist in their resolution.

Registration and coaching fees are strictly non-refundable.

The club reserves the right to suspend or expel from the club any player or member for failing to abide by the regulations and/or codes of the behaviour. Expelled players/members will not be entitled to a refund of any kind.

Players shall not be permitted to train or play unless membership has been paid in full. The club reserves the right to withdraw any player or team that has not paid in full all Membership and/or Coaching fees by the 1st March 2010.

Coaching fees will only apply to certain teams by a decision made at Committee level or by the Head Coach or at a team level. Independent confirmation of applicable costs will be made once final teams for the season are announced. Coaching Fees are over and above registration fees.
